1. WELCOME, INTRODUCTIONS, AND ROLL CALL

3. APPROVAL OF MINUTES

A motion was made by Bryon Reed to approve the December 16, 2016 R7BHB meeting minutes. The motion was seconded by Gayle Snowden. Motion passed.

4. 2nd QUARTER FINANCIAL REPORT

The 2nd quarter financial report was given by Randy Rodriquez. Total revenue from contracts was \$12,498.00. Expenses, including personnel costs, were \$5,161.87. The account balance is \$39,058.15, which includes prior FY carry over.

5. CHILDREN'S MENTAL HEALTH (CMH) COMMITTEE REPORT

There were 27 people in attendance at the CMH committee meeting held earlier. There is a lot of interest in children's mental health issues in our region. The committee discussed respite funds availability to children with Severe Emotional Disturbances (SED). Respite care will be available two Saturdays a month for four hours and will be for children ages 5-17 with or without insurance. Services will begin in Idaho Falls, Blackfoot, and Rexburg.

Dave Peters heard back from three of the schools he contacted regarding the Paper Tigers video.

Teriann Parker made a motion to the Board for the approval of \$225.00 for the purchase of three copies of the Paper Tigers video for the Lemhi County, Fremont County, and Jefferson County schools who requested a copy. Tracy Sessions seconded the motion. Motion passed.

Teriann Parker made a motion for the R7BHB to approve the purchase of 5,000 additional Respite "dollar" flyers. The motion was seconded by Darin Burrell. Motion passed.
