- Randy Rodriguez reported on the Year-to-Date (YTD) FY2018 financials. Total revenue is \$29,170.00. Total expenditures are \$28,205.87. The YTD balance is \$964.13. With carryover dollars from previous years, the current fund balance is \$50,249.02.

#### **9. CHILDREN'S MENTAL HEALTH (CMH) COMMITTEE REPORT**

- Teriann Parker reported she is continuing to work with Compass Academy on the events for Children's Mental Health Awareness Week in May. The plans for CMH Awareness Week are tied directly to objectives in the Strategic Plan (Outcome objective 3.3: Assist in developing and implementing positive behavioral interventions and supports in schools that address social emotional needs, substance use prevention, and suicide prevention education).
- There were several updates on Youth Empowerment Services (YES). Please see the CMH meeting minutes for more details.

#### **10. COMMUNITY REPORTS**

- Commissioner Todd Smith reported on the Madison Cares "Start with Hello" campaign. Start With Hello! teaches students, grades K-12, the skills they need to reach out to and include those who may be dealing with chronic social isolation and create a culture of inclusion and connectedness within their classrooms, schools and community.
- Janet Goodliffe announced the Idaho Children's Trust Fund has \$5,000.00 in scholarships available to attend the Strengthening Families Training Institute on March 6 and 7, 2018. More information can be found at <http://idahochildrenstrustfund.org/>.
- John Tanner stated that NAMI (National Alliance on Mental Illness) strongly supports House Bill 464 (Idaho Health Care Plan) and House Bill 465 (Dental services covered by Medicaid).
- Commission Bryon Reed provided additional information on House Bill 464.

**Motion: Commission Bryon Reed made an amended motion to draft a letter to be sent to Russell Barron at the Idaho Department of Health and Welfare from the R7BHB in support of House Bill 464. He provided the following wording to be used in the letter: The Region 7 Behavioral Health Board strongly supports House Bill 464 (Idaho Health Care Plan). We support your efforts on behalf of this legislation. Please continue to use your influence to advocate for this bill.**

- Sam Hulse presented information on the Weighted Blanket Project. Inmates in all Idaho correctional facilities are making the weighted blankets. The blankets are used as a sensory tool for people with anxiety and other disorders. The project is in need of donations of fabric, pellets, and batting. Mimi Taylor will send out additional information when it becomes available.
- Crystal Campbell announced that nominations for Mental Health Awareness Month awards are due by March 31, 2018. Crystal will send information to Mimi Taylor for distribution to Board members.
- Darin Burrell reported that on February 22, 2018, at 10:00 a.m., Fremont County is sponsoring a "Darkness to Light" training. This training focuses on child sexual abuse prevention. There is no cost for this training and CEUs are available. The community, elected officials, law enforcement, teachers, and counselors are welcome to attend.
- Darin Burrell also provided information on House Bill 577, Cannabidiol oil. The bill has a lot of support throughout the State. If you have any concerns about this bill, please contact your legislator.
- Michele Osmond thanked the Board for sponsoring the Accelerated Resolution Training. She reported that it was an excellent training and she has been using it in her work at the State Hospital. Melanie Fowers and Chip Snowden expressed the same sentiment.
