### 3. APPROVAL OF MINUTES

### 4. BOARD SEAT RATIFICATION

Cheryl O'Connell has applied for the Board position of Parent of a Child with a Substance Use Disorder, vacated by Chip Snowden's resignation. The appointing authority has approved the application.

**Motion:** Commission Bryon Reed made a motion to ratify the appointment of Cheryl O'Connell's to the Region 7 Behavioral Health Board. **Seconded by Shawn LaPray. Motion passed.**

### 5. FINANCIAL REPORT – July 2018

Randy Rodriquez reviewed the new format of the Financial Report. Janet Goodliffe requested a column be added for percentage spent YTD to help better track expenses.

Total revenue is \$4166.00 and total expenditures are \$1,801.49. The YTD balance is \$2,364.51. With carryover dollars from previous years, the current fund balance is \$56,291.65.

### 6. OPEN ITEMS:

- **Housing Report** - Michele Osmond attended a Housing Meeting with the Idaho Behavioral Health Planning Council in April 2018 in Boise, ID. The meeting was attended by all the regions in

the State. They discussed changes happening with long-term housing and tax credit for apartment owners with homeless units on their property.

The Idaho Housing and Finance Association website, [www.idahohousing.com](http://www.idahohousing.com), provides information on Homelessness Service Programs. Housing needs in all the regions include available and affordable housing, supported housing, step down and diversion from hospitalization, safe and sober housing, and housing for individuals with challenging issues.

## **7. HEALTHY MINDS PARTNERSHIP PRESENTATION**

Rachel Blanton, Southwest District Health, presented information on the on Healthy Minds Partnership, which focuses on partnerships between schools and behavioral health agencies.

## **8. GAPS AND NEEDS ASSESSMENT**

The Gaps and Needs assessment is due to IDHW in early September. Mimi Taylor led a discussion with the Board to complete the assessment. Mimi Taylor emphasized the importance of tying the identified gaps and needs in the community directly back to the action items in the Strategic Plan.

## **9. GRANT REQUEST**

Melissa Child, Integrated Wellness, LLC, provided information and answered questions regarding her grant request to fund the Just Say Whoa to Bullying program. The Board identified several areas of concern about the grant including the curriculum not being evidence-based and the fact that Integrated Wellness is a for profit business.

**Motion: Janet Goodliffe made a motion to deny the grant request to fund the Just Say Whoa to Bullying program. Seconded by Darin Burrell. Motion passed.**

- Darin Burrell reported on the following:
  - Family Engagement Training sponsored by District 7 Juvenile Justice, Monday, August 27 from 1:00 pm – 5:00 pm at Eastern Idaho Public Health (1250 Hollipark Drive, Idaho Falls).
  - On October 16, Juvenile Justice will be collaborating with the Rexburg Police Department and Community Youth in Action to have the Office of Drug Policy show "Chronic State", a documentary about what is happening in Colorado with the marijuana issue. More information to follow.
- Shauna LaPray reports that Eastern Idaho Regional Medical Center's assessment process has made some changes. They are now using tele-assessments. They are currently trying to solve some issues with wait times and the problem should be resolved soon. 
### 13. AJOURNMENT
